Appendix A

ROMANIAN CITIZENS, OF THE MEMBER STATES OF THE EUROPEAN UNION, OF THE STATES BELONGING TO THE EUROPEAN ECONOMIC SPACE AND OF THE SWISS CONFEDERATION

The registration file will contain the following documents:

- **1.** Standard application (CNRED) for the recognition and equivalence of studies done abroad, completed in all sections, in two copies, for:
- Recognition of the Baccalaureate Diploma obtained abroad : <u>Application</u> formed or Application form
- Recognition of university studies, with a view to admission to master's / doctorate / DPPD university studies : <u>Application</u>
- **2.** The documents attesting to the previous studies copy and legalized translation which allow the person in question access to the respective form of education.
- baccalaureate diploma and transcript (or equivalent), for enrollment in undergraduate university studies
- bachelor's degree and transcript (or equivalent), for enrollment in master's and doctorate university studies
- master's degree or advanced studies and transcript (or equivalent), for enrollment in doctoral university studies;

Documents must be authenticated by the relevant authorities in the issuing country. Authentication of study documents subject to recognition/equivalence:

- 1. diplomas from the Republic of Moldova do not require apostille or legalization . Diplomas issued before 2008 (as well as diplomas issued after 2008 that cannot be <u>verified through the portal</u>) will be accompanied by the original <u>Certificate of Authenticity issued by the Ministry of Education of the Republic of Moldova;</u>
- 2. for the states that are parties to the Hague Apostille Convention, the documents of studies subject to equivalence/recognition must be endorsed with the Hague Apostille by the competent authorities of the issuing countries; study documents from Italy, Greece, Spain, Portugal and Cyprus will be endorsed with the Apostille of the Hague Convention, the other EU member states being exempt;
- 3. for states that are NOT parties to the Hague Apostille Convention, study documents will be <u>superlegalized</u> or will be accompanied by the Certificate of Authenticity issued by the competent authorities of the country of origin;
 - superlegalization is applied by the Ministry of Foreign Affairs of the issuing country, the Embassy/Consular Office of Romania in that country and the Ministry of Foreign Affairs of Romania or by the Ministry of Foreign Affairs of the issuing country and its Embassy/Consular Office in Romania and the Ministry of Foreign Affairs of Romania; for countries where there are no diplomatic missions of Romania or which do not have diplomatic missions in Romania, the study documents will have the visa of the Ministry of Education and the Ministry of Foreign Affairs of the issuing country;
 - the exemption from over-legalization is allowed under the law, of an international treaty to which Romania is a party or on the basis of reciprocity.


- **3.** Copy and legalized translation * of the certificate attesting the passing of the Baccalaureate exam for graduates of the current year (as the case may be, if necessary);
- **4.** Transcripts or the supplement to the diploma copies and legalized translations * related to the studies carried out and the analytical program, in the case of candidates who request the equivalence of some study periods;
- **5.** Certificate of completion of the Romanian language year or certificate of linguistic competence, as the case may be;
 - **6.** Birth certificate copy and legalized translation *;

*In accordance with the provisions of REG. (EU) 2016/1191, for candidates who have completed their studies in France, translations of documents by an authorized person from France are accepted, without the need for other legalizations.

- 7. Copy of the document certifying permanent residence abroad (if applicable);
- **8.** Copy of the identity document;
- **9.** For doctoral candidates: curriculum vitae in European format and list of published scientific works (if applicable);
- **10.** The medical certificate (in a language of international circulation), certifying that the person about to enroll in studies does not suffer from contagious diseases or other conditions incompatible with the future profession;
 - **11.** Marriage certificate if needed to prove name change;
 - **12.** For student candidates: proof of student status;
- 13. For the children of active teaching and auxiliary teaching staff (pre-university and higher education), a certificate with the visa of the School Inspectorate or of the educational unit, and for orphaned children or of retired teaching and auxiliary teaching staff, supporting documents (for tax exemption registration);
- **14.** For the children of employed or retired staff of the ULST, as well as for its employees, a certificate issued by the Human Resources Directorate for exemption from the registration fee;
- **15.** Other documents requested by CNRED , if applicable: https://www.cnred.edu.ro/ro/recunoastere-studii-cetateni-europeni-admitere-licenta-in-Romania
- For the exercise of a regulated profession (in the case of study documents obtained in third countries): the analytical programs of the courses completed, the complete description of the courses/subjects studied, documents related to the completion of postgraduate courses, etc.: copy for the Romanian/English/French/Spanish languages / Italian and certified copy and translation for the other foreign languages
- Example: Pruebas de Aptitud para el Acceso a la Universidad , qualification Apto from Spain; Scholastic Aptitude Test (SAT) or US ACT, etc. legalized copy and translation, with the exception of study documents in English, French, Spanish and Italian
- Example: Foreigners, family members of Romanian citizens, holders of a right of temporary residence, must submit proof that they are employed or registered unemployed in order to benefit, under the law, from equal treatment with Romanian citizens in terms of registration at studies . (OG no. 194/2002 regarding the regime of foreigners in Romania with subsequent amendments and additions, republished, art. 80 para. (3) letters b) and c))

- **19.** Proof of the registration fee (if applicable, paid for each application submitted), to be paid in Euros to the ULST account;
