CAP. I. FIELD OF APPLICATION

Art. 1. (1) This regulation establishes the general framework for the organization and operation of the Didactic Commission of the Senate within the University of Life Sciences "King Mihai I" from Timișoara (ULST).

(2) The regulation applies to the members of the Didactic Commission of the Senate, within the University of Life Sciences "King Mihai I" from Timișoara.

(3) Users of the regulation are responsible for applying and complying with the provisions of the documents in this regulation.

CAP. II. PURPOSE

Art. 2. The purpose of the elaboration of this regulation is to establish unitary rules regarding the way of organization and operation of the Didactic Commission of the Senate of the University of Life Sciences "King Mihai I" from Timișoara (ULST).

CAP. III. DEFINITIONS. ABBREVIATIONS

- **ULST** - University of Life Sciences "King Mihai I" from Timișoara.

CAP V DESCRIPTION OF THE REGULATION

Art. 6. The teaching committee of the Senate represents the specialized structure of the Senate of the University of Life Sciences "King Mihai I" from Timișoara (ULST) responsible for the professional training activity through bachelor's, master's, doctorate, postgraduate studies and continuing education courses .

Art. 7. The Didactic Commission of ULST is composed of nine members, seven teaching staff and two students, representing each faculty of the University.

Art. 8. The operative management of the Teaching Commission is ensured by its president. He collaborates directly with the vice-chancellor with education and quality assurance at the University in solving all the problems arising in this department.

Art. 9. The didactic commission of the Senate aims to apply the legal procedures established regarding the content and evolution of the educational process in all fields of study within the University of Life Sciences "King Mihai I" from Timișoara (ULST) having attributions in relation to:

- a) analysis of faculty proposals regarding the establishment and development of new study programs;
- b) analysis of the opportunity of proposals to diversify some forms of education within the University;
- c) monitors and ensures the application of all regulations regarding teaching activity and quality assurance;
- d) analyze analytical courses and programs at the level of the University's faculties ;
- e) verifies the correctness of the contests for teaching positions within the University and is responsible for drawing up the final report for the exams held for teaching positions in the University;
- f) analyzes and formulates answers to the letters and memos received.

Art. 10. The didactic commission meets for specific problems, without having an established periodicity, whenever necessary, when convened by its president.

Art. 11. The didactic committee adopts decisions that are subject to final analysis and approval by the ULST Senate plenary

Art. 12. The meetings of the didactic committee are legally constituted if half plus one of the total number of members are present, and decisions are adopted by a simple majority (half plus one of the number of members present at the meeting).

Art. 13. Both at the ordinary and at the extraordinary meetings, the didactic Commission of the Senate can invite other people outside its composition.

Art. 14. The president of the didactic committee of the Senate informs the Senate, as the case may be, about the activity carried out.
