CAP. I. FIELD OF APPLICATION

Art. 1. (1) This regulation establishes the manner of conducting the contest for the awarding of the URSUS nominal scholarship within the University of Life Sciences "King Mihai I" from Timisoara (ULST).

URSUS scholarship awarding competition within the University of Life Sciences "King Mihai I" from Timisoara.

(3) Users of the regulation are responsible for applying and complying with the provisions of the documents in this regulation.

CAP. II. PURPOSE

Art. 2. The purpose of the elaboration of this regulation is to establish unitary rules regarding the organization of the URSUS scholarship competition within the University of Life Sciences "King Mihai I" from Timisoara, scholarships funded by the sponsorship granted by the URSUS BREWERIES Commercial Company TO



CAP. V. DESCRIPTION OF THE REGULATION

CAP V.1. preamble


- Art. 6. The Commercial Company URSUS BREWERIES SA sponsors the University of Life Sciences "King Mihai I" from Timisoara in order to grant a number of scholarships for students in the 3rd and 4th year of the bachelor's degree and the first year of the master's level (valid for the programs of studies that require 4 years of study, including year 5 and 6 Faculty of Veterinary Medicine) and years 2 and 3 for the Biology study program within the Faculty of Agriculture, within the "URSUS Scholarship Student for the Community" program. The granting of these scholarships is carried out by the University, on a competitive basis.
- Art. 7. Through this Regulation relating to the conduct of the "URSUS" nominal scholarship awarding competition hereinafter the URSUS Scholarship Regulation the terms, conditions, criteria that must be met by those who enter the competition, the necessary documents, the designation and composition of the Commission are established competition, the procedures to be followed and other aspects related to the awarding of URSUS scholarships for the current academic year.

CAP V.2. SCHOLARSHIP FUND

- **Art. 8** . (1) The size of the scholarship fund of the University of Life Sciences "King Mihai I" from Timişoara for the current academic year from the sponsorship granted by SC URSUS BREWERIES SA is **10,800 lei.**
- 3 scholarships worth 400 lei per month will be awarded for 9 months.

CAP V.3. PARTICIPATION AND REGISTRATION IN THE COMPETITION

Art. 9 . (1) Students in the 3rd and 4th year of the bachelor's degree and the 1st year of the master's degree have the right to participate in the nominal scholarship awarding competition (valid for study programs that require 4 years of study, including the 5th and 6th year - Faculty of Medicine Veterinarian) and years 2 and 3 for the Biology study program within the Faculty of Agriculture, with the mention included in the article art. 19 of this regulation. Only full-time students can participate in the competition, who obtained a minimum average of 8 in the previous semester and who have academic conduct demonstrated by a letter of recommendation from a university teacher.





- (2) At the same time, the student must prove an intense activity for the benefit of the community through a letter of motivation, accompanied by a certificate from each organization within which he/she has carried out/carries out this type of activity.
- **Art. 10** . The announcement of the organization of the contest, together with the calendar of events, will be made public by posting at the address http://www.usab-tm.ro/. Students who meet the criteria established in art. 9 of the present URSUS Scholarship Regulations and who will submit the following documents at the latest on the date announced in the performance calendar:
- a) Standard application addressed to the University of Life Sciences "King Mihai I" from Timisoara - Annex 1 to the URSUS Scholarship Regulation which is available on the website http://www.usab-tm.ro/;
- b) Declaration of collection of personal data of the "URSUS-Students for the Community" scholarship holders **Annex 2**;
- c) Certificate from the faculty certifying the general average for the last completed semester;
- d) Letter of recommendation from a university teaching staff;
- e) Curriculum Vitae;
- f) Letter of motivation in which the student must present:
- the non-profit, non-governmental, non-political organizations of which he is or was a part during his university studies;
- the position held within them and in what period;
- the activity carried out within them, projects coordinated and/or initiated and/or in which he was involved within these organizations and the results of these projects;
- g) Participation in the community involvement projects mentioned in the motivation letter must be confirmed by original certificates.
- **Art. 11** . (1) The deadline for submitting files is the date announced in the development calendar displayed at http://www.usab-tm.ro/.
- (2) On the date established according to the performance calendar displayed at http://www.usab-tm.ro/, The pro-rectorate of social and student activities within the University of Life Sciences "King Mihai I" from Timisoara will submit the candidates' files to the Competition Commission.
- Art. 12. The documents provided for in art. 10 are deposited in a plastic file with a rail, at the headquarters To the vice-rector's social and student activities within the University of Life Sciences "King Mihai I" from Timisoara, (Rector's Building), Calea Aradului no. 119, 300645 Timişoara, Timiş county, Romania, from Monday to Friday, between 9:00 a.m. and 12:00 p.m.. At the end of registration, the files are submitted to the Competition Committee.




CAP V. 4. COMPETITION COMMISSION

- **Art. 13.** (1) The competition committee will be appointed by the Rector's Decision, based on the approval of the Board of Administration.
- (2) A representative of SC URSUS BREWERIES SA is also part of the Competition Commission, with observer status, not having the right to vote in the evaluation.
- (3) The list of members of the Competition Commission is public, displayed at the address http://www.usab-tm.ro/ .
- **Art. 14.** In order to resolve possible appeals by the same decision, an appeals analysis Commission consisting of three persons, other than those from the Competition Commission, will be nominated.

CAP V.5. CONDUCT OF THE COMPETITION

Art. 15. (1) The competition committee classifies the students according to the points obtained, taking into account the fulfillment of the following criteria (**Annex 3**):

- (2) The final ranking is made based on the score obtained by each candidate and is made public by posting at the address http://www.usab-tm.ro/.
- (3) Candidates declared winners of the scholarships will sign the Declaration attached to the Regulations.
- (4) Competition results can be contested within 3 days of posting. The appeal is submitted to the Secretariat of the Vice-Rectorate for Social and Student Activities and will be resolved within a maximum of 24 hours from registration. The decision of the Appeals Analysis Commission is final. The list of winners, signed by all the members of the Commissions, is displayed at http://www.usab-tm.ro/.
- **Art. 16** . The number of scholarships will be distributed across the two study levels (bachelor's and master's) according to the criteria established by mutual agreement with the company SC URSUS BREWERIES SA

CAP V.6. TERMS OF PAYMENT OF THE SCHOLARSHIP

- **Art. 17.** The payment of the nominal scholarship will be carried out by the University based on the final ranking displayed and the signing of a scholarship contract, the signing of which is conditioned by the execution of the sponsorship contract concluded with SC URSUS BREWERIES SA The URSUS nominal scholarship is granted for the entire period of the academic year in course and is paid monthly.
- **Art. 18** . In case of transfer of the scholarship holder to another higher education institution or expulsion, payment of the nominal scholarship ceases.



Art. 19. Based on these regulations or the scholarship contracts, the scholarship holders have no contractual obligation towards SC URSUS BREWERIES SA, which offered the sponsorship. Exceptionally, scholarship holders may be requested to participate in various events or press campaigns to talk about the URSUS scholarship program, participation to be determined by mutual agreement.

CAP V.7. ACCESS TO INFORMATION REGARDING THE ORGANIZATION AND CONDUCT OF THE COMPETITION

- **Art. 20.** All information regarding the organization and conduct of the competition can be obtained by accessing the website: http://www.usab-tm.ro/.
- **Art. 21**. The information about the contest winners is public and will be included in the University's official information sources (on the university's website: http://www.usab-tm.ro/).
